## Meeting Rooms and Rates for the City of Grande Prairie

## **DEFINITION OF USER GROUPS:**

#### Conventions:

Groups with more than 200 delegates whose functions last longer than 6 hours per day (not including set up or clean-up time).

## Commercial:

Groups holding training seminars, or profit motivated functions such as lectures, concerts, theatrical productions whose functions are less than 6 hours per day, or for less than 200 people.

## **Adult Programming:**

Service or community groups who offer a course or program and charge a fee (e.g. St. John's First Aid).

### Adult Recreation/Leisure:

Groups that provide leisure entertainment or recreational activity for their members (e.g. Men's Basketball, Chess Club).

#### Adult Non-Profit/Service:

Groups that provide a service to the community and do not charge a fee (e.g. Single Parent Association). Church groups would also be included in this category.

# **Youth Programming:**

Groups that provide instruction or recreation programs for youths under the age of 18 years and charge a fee (e.g. Red Cross Babysitting, Aerobics).

# **Non-Profit Youth:**

Groups that provide instruction or recreation programs for youths under the age of 18 years. Those groups may charge a membership fee but offer an "ongoing" program.
